### Statement of Understanding

I understand that the Department of Veterans Affairs formally establishes eligibility for the Post-9/11 GI Bill's Yellow Ribbon Program and that this request for participation is contingent upon the VA's approval for such benefits. - I served an aggregate period of active duty after September 10, 2001 of at least 36 months;
- I was honorably discharged from active duty for a service-related disability and I served 30 continuous days after September 10, 2001; or
- I am a dependent eligible for the Transfer of Entitlement under the Post-9/11 GI Bill based on a veteran's service under the eligibility criteria listed above.

I affirm that I am enrolled at Middlebury College, and I understand that I must apply to the VA for a Certificate of Eligibility to qualify for the Yellow Ribbon benefit. Failure to submit a timely Certificate of Eligibility to the VA may result in removal from the Yellow Ribbon participant list.

I acknowledge that the Yellow Ribbon program funds are distributed on a first-come, first-served basis, measured from the date on this request for participation form. I understand that submitting this form does not guarantee my admittance to the Yellow Ribbon program. I also understand that Middlebury is not required to make Yellow Ribbon program contributions if I am not in good academic standing.
