We understand that Middlebury reserves the right, at its discretion, to withdraw its consent to our use of its facilities in accordance with its policies for non-college events. We further understand that we need to provide proof of general liability insurance coverage for the Event in the amount of One Million Dollars (\$1,000,000.00) in order to reserve the facilities listed above. We understand and acknowledge that while Middlebury may oversee certain aspects of the Event, it does not represent us or act as our agent for purposes of this Event.

We waive any right we may otherwise have to sue Middlebury for injuries or losses arising from the Event and the use of the Middlebury's facilities, including claims for negligence on the part of Middlebury, its agents or employees.
