Section 1: Experience/Internship Agreement

As an intern, I agree to carry out the responsibilities designated by my internship sponsor to the best of my abilities and to pursue completion of individual learning objectives. In addition, I understand and agree to the following conditions for receiving credit through Middlebury College:

- a) I will participate in any pre-departure training required by the Center for Careers and Internships (CCI) and will complete this experience/internship as described in my Handshake experience credit/funding application. I agree to notify CCI should the length of my experience/internship and/or my responsibilities change.
- b) I will fulfill the academic requirements as determined by my faculty academic sponsor and submit a final academic assignment to this faculty member. I will incorporate the academic sources listed in my application for credit in this final work.
- c) I will complete a reflection blog post on the Experiential Learning Lifecycle Hub during my experience as instructed by CCI.
- d) I will complete and/or ensure submission of the following to CCI by February 9:
 - a. Self-reflection essay and evaluation (student submits)
 - b. Supervisor evaluation (internship on-site supervisor submits)
 - c. Donor thank-you letter (if you have received a WT funding grant)
 - d. Two photographs that capture your experience uploaded to your Handshake Experience (optional)

These documents, in part or their entirety, may be made available to students, the selection committee, the award providers, College faculty, and staff.

e) International experiences/internships: I will abide by any travel restrictions set in place by Middlebury College. If traveling, I will research and complete any necessary visa paperwork for that country, ensure that I have adequate international health insurance, complete Middlebury's travel registration and any other paperwork that may be required for travel to countries with a travel advisory.

Please note: If traveling to a country with a state department travel warning of 2 or more, I will complete additional paperwork for the Middlebury Global Operations Committee. This applies to students traveling to or already located in their home country. See FAQs at <u>go/WTinternships</u> for additional information.

- f) If funding is awarded, I understand that I will receive the award amount via direct deposit (unless otherwise specified). *Awarding of funding is dependent on* receipt of this agreement, the internship sponsor agreement, the academic sponsor form, and completion of the direct deposit form. I understand that I may only receive one Winter Term funding grant during my time at Middlebury. International students: Please note that taxes may be withheld from your grant, so the amount of your grant may be less than the amount listed in your award letter.
- g) I acknowledge that if I do not submit my self-reflection essay, evaluation, and other required paperwork by February 9, credit for the experience may be in jeopardy. Requests for extensions due to extenuating circumstances should be e-mailed to Cheryl Whitney Lower (clower@middlebury.edu).
