

SUMMARY ANNUAL REPORT

For Middlebury College Voluntary Retirement Plan

This is a summary of the annual report for Middlebury College Voluntary Retirement Plan, EIN 03-0179298, Plan No. 004, for period January 1, 2022 through December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$18,082,867. These expenses included \$86,578 in administrative expenses, \$17,983,233 in benefits paid to participants and beneficiaries, and \$13,056 in other expenses. A total of 2,411 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$269,425,824 as of December 31, 2022, compared to \$312,512,837 as of January 1, 2022. During the plan year the plan experienced a decrease in its net assets of \$43,087,013. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of (\$25,004,146), including employee contributions of \$6,404,085, including other contributions of \$ 2,660,564, earnings from investments of (\$33,913,162), and other income of (\$155,633).

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (President & Fellows of Middlebury College, 152 Maple Street, Middlebury, VT 05753) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs. Paperwork Reduction Act Statement
