SUMMARY ANNUAL REPORT

FOR MIDDLEBURY COLLEGE CORE RETIREMENT PLAN

This is a summary of the annual report Form 5500 Annual Return/Report of Employee Benefit Plan for Middlebury College Core Retirement Plan, EIN 03-0179298, Plan No. 005, for period January 1, 2023 through December 31, 2023. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a single-employer defined contribution plan.

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$28,088,094. These expenses included \$203,987 in administrative expenses, and \$27,884,107 in benefits paid to participants and beneficiaries. A total of 3,054 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$515,966,322 as of December 31, 2023, compared to \$455,364,556 as of January 1, 2023. During the plan year the plan experienced an increase in its net assets of \$60,601,766. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$88,689,860, including employer contributions of \$14,626,824, employee contributions of \$6,218,248, earnings from investments of \$66,998,585, and other income of \$846,203.

Minimum Funding Standards

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.

- Assets held for investment;
- Insurance information, including sales commissions paid by insurance carriers;
- Information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.

charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
